887 <u>Police Report</u>- since the presence of the Go-safe vehicle there had recently been 22 cases of speeding in the valley and 3 where safety belts were not being worn. Since recent concern about trees falling close to the B4500 PCSO Griffiths had arranged to meet Mr Elton Watson WCBC on Mar 8 to discuss the problem.

There is particular concern about the use of cocaine and heroin in the valley and members were asked to be vigilant and to report any suspicious behaviour to the Police.
