<u>106 Police Reports</u> – PCSO Dan Sawyer explained that the format for reporting would change forthwith. Recent crimes reported in the Glyn Valley district were;

1 x criminal damage (Fire), 1 x animal wildlife offence (dead goshawk), 1 x burglary (chainsaw & lawnmower stolen)

ASB - 4 incidents (3 at same address), 1 x youth asb,; 2 domestic

10 speeding tickets issues by GoSafe on the B4500 Pontfadog.

Operation targeting illegal off-roading completed on Sat 24 March; 33 vehicles stopped; I made off; I seized – no insurance; 1 penalty possession of cannabis; 2 VDRS issued. Operations will continue.

<u>108 Planning - Notice of a planning application for an artist's studio conversion at Pen Y Bryn had been received. There were no comments.</u>

109 Roads & Lighting - It was noted that the Llanarmon-Rhiwlas- Rhydycroesau road was in a poor state. Cllr Greatorex has been in touch with Powis Council & Ken Skates. Clerk will follow this up with Clr Phil Davis, Powis Highways.

Cllr Bates (WCBC) noted that the chippings piled at Herber corner on the B4500 were now being removed, as the Water Utilities are to start digging up the road! Daren Williams, head of highways & the environment at WCBC said that this work should now be completed at the back end of the year.

High Speed Fibre – Cllr Bates (WCBC) reported that he was previously informed in December that this would be done before the end of March. He is now informed that all plans have now been abandoned! Cllr Greatorex has paid for high speed fibre in The Hand. It is also in The West Arms.

L.D.P - Consultation period for LDP ends 31 May. WCBC approved deposit LDP on 28 March 2018.

Wales Ambulance – Cllr Bates (WCBC) has been in communication regarding holding a public meeting in the valley to discuss response times. A meeting was scheduled for 11 June in the Oliver Jones Memorial hall but has now been postponed.

Pontfadog School Consultation – WCBC voted on April 10 to close the school. However, there were many inconsistencies in their process & this may lead to further objections.
