A letter has been received from the Church Wardens of St.Garmon's informing the Council of the Parochial Church meeting's decision to become a Pilgrimage church. The clerk to write expressing the Council's support of St.Garmon's.

Planning – Powys Council had sent information regarding a planning application P12017.0255 for installation of wind turbine up to max. height of 101m, at Cefn y Maes, Rhydycroesau, Oswestry. No comments were made.

Graveyard Inspection – The annual graveyard inspection was made on Fri 5 May by Cllrs F.Evans-Swogger & G.M.Jones. Five gravestones were found to be in need of attention & a list has been handed to the clerk.

Footpaths – A letter has been received, addressed to Ifor Richards, concerning the footpaths from the village to Tregeiriog. The complaint mainly concerned the height & difficulty of the climbing stile. Clerk to forward letter to WCBC.

Cllr Evans-Swogger noted that Teddy's bench was in need of some T.L.C & would make enquiries. Cllr Edwards noted that there were weeds growing through coping stones on the bridge, which needed attention – clerk to contact Kevin Edwards.

Cllr E.W Morris suggested a bin was necessary at the Nant Swrn layby, as rubbish was being left by those parking there.
