025 Public Conveniences

Cllr Barbara Roberts (WCBC) informed us that the Public loos in Glyn Ceiriog were costing just over £4000 per year. Cllr EW Morris suggested that the current arrangement costing £500 p.a represented good value. Perhaps the signage on the closed loos, showing the alternatives, could be clearer. Cllr Evans-Swogger happy to help with notices but will need help fixing them securely.

<u>026 Land Adjacent to Tregeiriog Water works</u> – The clerk has received a letter from Pannone & Partners representing Dee Valley Water Plc, enquiring as to whether CUCC would like to open discussions to enter in to a new lease in respect of the land at Tregeiriog. In view of the facts that nobody used the facility, it cost £500 p.a. in upkeep & is adjacent to dangerous water, it was voted unanimously NOT to take matters further.
