Any further news on public conveniences/Hall – Denise Garland WCBC has been in contact with the Hall Committee. Apparently on Nov 1<sup>st</sup> 1997, a new lease was granted for the loos for 60 years. However, this was never signed by the Hall representatives. To transfer this lease to the Hall would involve £600 legal fees already incurred. WCBC would be willing to waive £250 surveyors' fees. The Community Council generally considered that it would be supportive of the Hall committee in their efforts to obtain control of the public convenience building & they should be free to negotiate its future with WCBC.

Broadband – Cllr T Bates (WCBC) has been making enquiries of BT regarding plans for Llanarmon. Currently there are no plans for Broadband outside 1.5km from the recently installed box. He will make further enquiries, as there was some doubt about this.

Cllr F Evans-Swogger noted that the doors on the telephone exchange were in poor condition which was not a great 'welcome' to the village. Clerk to make enquiries.

Cllr EW Morris enquired as to whether there have been complaints re speeding in the new 20mph zone in Pontfadog. Cllr T Bates (WCBC) reported that there have been.
