#### **Matters Arising**

## 097 Police Report -

January crime reports showed the usual theft from sheds and a spike in assaults. This however relates to one property. The most common complaints relate to off-road issues and the police have been active in this area.

#### 098 Off-Roading -

Cllr T Bates (WCBC) reported that he had been communicating with local off-road groups through social media but the response had largely been negative & abusive. Cllr Benning commented that this was a complex problem & the police have become more involved than they were previously. However, there was still potential for an incident & care should be taken. He proposed a vote of thanks to Cllr Bates; we have never been served so well by a County Councillor and this was felt by all.

# 099 Finance/Bank -

<u>The</u>\_balance as at Jan  $3^{rd}$  was £6,390.82. Two bills had been received – one from Wales Audit Office for £164.25 and one from Vision ICT Website Hosting & Support for £150. Authorisation was given to pay these.

# 100 Community Agent -

Should we require assistance with being put in touch with the right organisations such as Association of Voluntary Organisations or Dementia Champion WCBC, she would be very happy to help.
