# 146 Police Reports / Off-roading

Cllr Bates (WCBC) reported that comments seen on the GLAS website had been reported to Inspector Steve Owens, as they were viewed as very serious & threatening. There have been more complaints recently as 4 x 4 activity has picked up. Cllr Bates reported that contrary to GLAS principles, off-roading has been reported throughout the night. Cllr Bates commented that this was frightening for elderly people living in the countryside.

# 147 Ambulance Response Times/Defibrillator

Cllr Greatorex reported that a suitable site may have been located in Tregeiriog. The chairman would make further enquiries. Cllr Evans-Swogger has made further enquiries about using the 'phone box as a home for the defibrillator. She had a meeting with Cadwyn Clwyd, who are encouraging alternative useage of old 'phone boxes. However, they require £700 in match funding, It was felt that the Community Council were not willing to take on ownership of a listed building which is leaning towards a stream, in light of current concern regarding the culvert. The site on The Hand is well-lit & covered by CCTV. Signs should be obtained from Welsh Hearts to advertise its location. The Chairman thought it a good idea to write to each household once both were in place, informing of this & available training.
